Include the following with the bid form: Letter of intent from facility, equipment and hotel vendors

Include a layout of the facility showing equipment placement

### Requirements for the Host Organization:

Facility must be large enough to accommodate 2- 3 sets of equipment and large spectator area

Facility should have decorations to include plants, flowers or balloons

Facility should have separate judges room to accommodate judges

Award area should be decorated and able to accommodate 200 people

Coaches hospitality: lunch will be served to coaches with back to back sessions

Gift for all athletes in the competition is required

AAI equipment is required - Electronic Scoring is required and must be approved by committee

### Host Club Responsibilities

Contracts for facility, equipment, hotel, and scoring equipment

Order and pay for Team Banners as per Florida USA Gym

Pay all expenses for Judges assigned to the competition including fees, transportation, hotel, meals including SINGLE Rooms for all judges

Order and pay for gift for all athletes in competition (to be approved by State Committee)

Organize and run event - obtain sanction

Pay for awards for Individual events and AA ( medals will be ordered by State Chairman)

Order and pay for Trophies if required for AA as indicated below

State Meet hosts will reimburse Florida USAG for awards/shipping expenses for all State medals except the Level 9 & 10 Meet – the State will pay for the awards for level 9-10

Official State medals or trophies are required as indicated below (paid for by Host Club)

Level 1/2 – Award 100% AA Trophies plus 50% plus 1 on each event with medals

Level 3, 4/5 & XCEL – Award 50% plus 1 on each event with medals plus 100% AA Trophies/medals

Level 6, 7, 8, 9, & 10 – Award 50% plus 1 on each event and AA with State medals

**Florida State committee reserves the right to determine exact number and type of awards to be given at all State meets for events, AA and Team**

**Fee to USAG Florida: No athlete fee is due to USAG**

### Entry Fees:

Level 1/2 State Meet \$75.00 per athlete

Level 3, 4, 5 & XCEL State Meet \$75.00 per athlete

Level 6, 7, 8, 9, & 10 \$90.00 per athlete \$50 Team fee all levels

### Door Fees: Maximum that may be charged

Adults \$15.00 per day Optional - \$20.00 per day

Child(12 – 5yrs) \$ 10.00 per day 4 & under Free

### Florida USAGYM Committee will do the following:

Approve all information sent out by host club

Select and assign all Judges to the competition – 4 judge panels for level 9/10 – 2 judge panel for all other levels/divisions - XCEL will be a double meet with 17 judges

Order State medals (paid by Host Club) Do draw and approve schedule for competition
