JUDGES AND COMPETITIVE COACHES CLINICS

These clinics will be geared toward Judges however we encourage coaches to attend as well. Sessions will review compulsory changes, JO optional changes, technique, how and why deductions are taken, as well as providing practice judging sessions and information on how to become a judge. We have set up 4 different sites for these clinics to keep travel expenses to a minimum for our membership. This year all optional ratings will expire in December of 2009 requiring all optional rated judges to re test—we will be offering the judges test at 2 of these sites and possibly at the others as well. All clinics will receive CPE credit. Our staff will consist of Florida brevet and national level judges—We hope all of you will take advantage of this great learning opportunity and we hope to see lots of coaches there too! Do you really want to know what “those judges” are thinking then sit in on these sessions including the practice judging and see what deductions are being taken, why they are being taken and what would the judges like to see— we will welcome your comments at all sessions.
